## Public hearing: TK length of school day

Jan. 7, 7 p.m., District Board Room

A public hearing will be held in order to comply with Education Code sections 33050, 37202. A general waiver request for Transitional Kindergarten Length of School Day for 2015-2016 and 2016-2017.

Currently, our district offers extended day for Kindergarten at all school sites (285 instructional minutes per day) and a regular day for Transitional Kindergarten students (200 minutes) at three school sites. The District feels that having Transitional Kindergarten students attend an extended day is not in their best educational interest and that our program provides students with developmentally appropriate experiential and academic activities that will prepare them for the more academically rigorous second year of our kindergarten program.

The public hearing will be held at the Mountain View Whisman School District Board Room at 750-A San Pierre Way on January 7, 2016 at 7:00pm.
