#### VII. COMMUNICATIONS

Trustee President Berman made the following statement, followed by a moment of silence:

"On the morning of October 7th 1,400 innocent Israeli citizens, including babies and children, were brutally murdered in a targeted terrorist attack by Hamas. 200 more were taken hostage. It was a horrific day for our Jewish community, a day of evil barbaric attacks not seen since the Holocaust. Since then, there have been more casualties of innocent civilians in Israel and Gaza. We stand with you and our hearts break for the pain you are experiencing.

In my work with the National Equity Project, I learned a traditional greeting that is used by the Masai people in Africa that translates: "And how are the children?" Here in Mountain View, the children may be physically safe, but many are not okay. We have families in our district and across our community - like mine - with ties to the region. I know they are suffering. They are deeply worried for their loved ones; some are mourning the loss of

family or friends that were taken from them. I also hear from our community members that they don't feel safe, that there is a feeling of fear similar to what was felt after 9/11 and similar terrorist attacks.

We are also troubled by a rise in hate-based acts across our country and even here in our own community. There is a rise in antisemitism and Islamophobia. However, even before the recent tragic events, our school district has been working hard to root out the seeds of hate in Mountain View. Our teachers will receive anti-bias/allyship training from the Anti-Defamation League in January, and all of our schools are working towards their No Place for Hate designation this year.

At the board level, in November 2021 we passed a resolution identifying one week in November as United Against Hate Week while also asserting our resolve to fighting hate and oppression year-round. We've chosen to renew that resolution annually, and I look forward to re-affirming our deep-seated commitment to this work at the next board meeting. Today, however, I use the privilege of my position to denounce acts of terrorism, discrimination, and hate, and to express the board's dedication to creating safe spaces across our schools that allow all students to learn and thrive, free from the threat of hatred and extremist violence. Every child is deserving of that.

Dr. Rudolph and our district staff have shared resources for families and staff to support our children at home and school. We also have additional counseling resources available for any student or staff member that are dealing with trauma. I encourage you to reach out to your principal or district leadership; we are here to help.

I'd like to conclude with a moment of silence for all the children and families that are experiencing pain, fear, and suffering at this time. (pause for a moment of silence)

Thank you for joining me in a moment of silence. We are truly hoping for better days ahead".
